THE PANDEMIC ALLOWED MOST PEOPLE TO FEEL ISOLATION AND LACK OF SOCIALIZATION THAT THE ATHLETES OF SPECIAL OLYMPICS WOULD EXPERIENCE ALL THE TIME WITHOUT THE PROGRAMMING THE ORGANIZATION OFFERS YEAR ROUND. THE ORGANIZATION HAD TO MOVE TO DOING ACTIVITIES ONTO A VIRTUAL PLATFORM AS WELL AS HOLD SMALL IN-PERSON EVENTS WITHIN ALL GUIDANCE FROM THE STATE. EVEN WITH ALL OF THE CHALLENGES AND WITH THE ASSISTANCE OF 4,459 VOLUNTEERS, IN 2020, SPECIAL OLYMPICS MASSACHUSETTS PROVIDED TRAINING AND COMPETITION IN 16 INDIVIDUAL AND TEAM SPORTS AND STAGED 96 ATHLETICS EVENTS.
